
## Newborn Feeding and Care Kit for Cleft Lip and/or Palate Infants

Add a personal touch and make the transition from the hospital to the home easier for parents of cleft lip and/or palate infants.

The purpose of this kit is to familiarize new parents with the different feeding procedures. It contains actual feeding items used by most parents of cleft infants, and a Feeding and Care Booklet.
